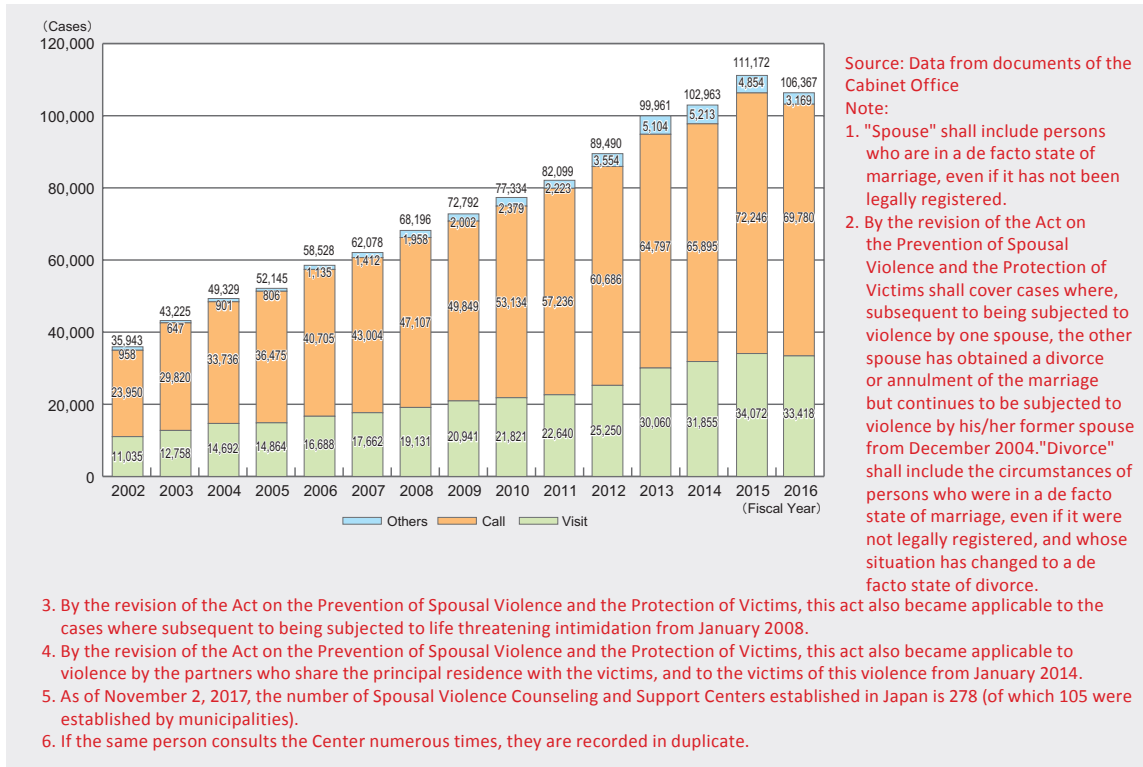


6. Violence against Women

■ Spousal Violence Situation

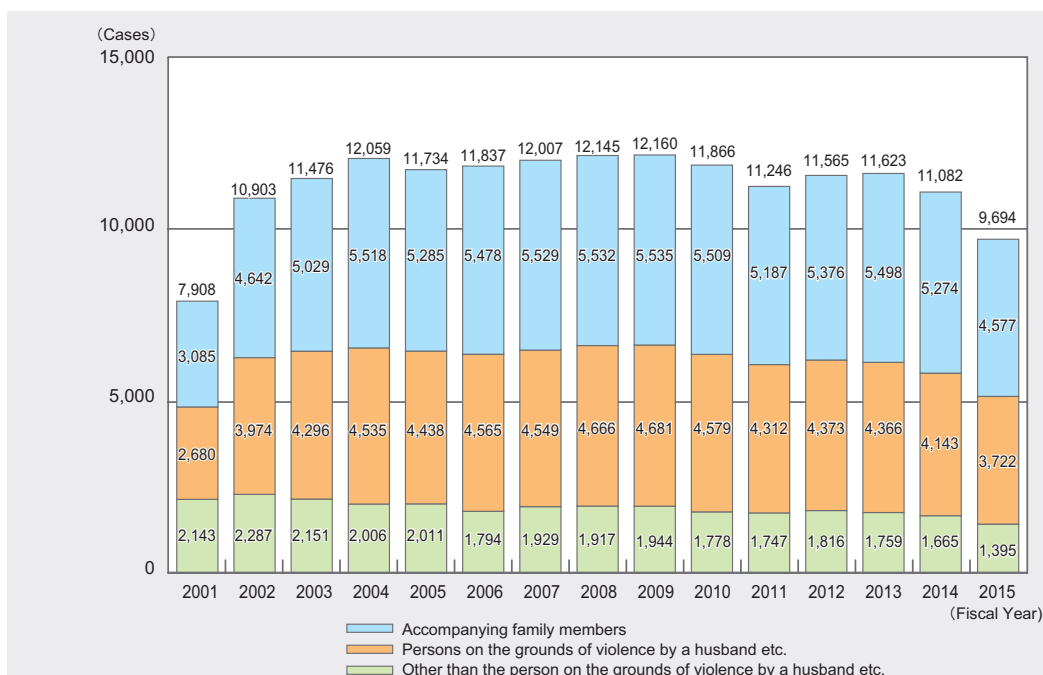
● Number of Consultations at Spousal Violence Counseling and Support Centers

The number of consultations at Spousal Violence Counseling and Support Centers have been over 100,000 cases since 2014.



● Number of Cases of Temporary Protection at Women's Consulting Offices

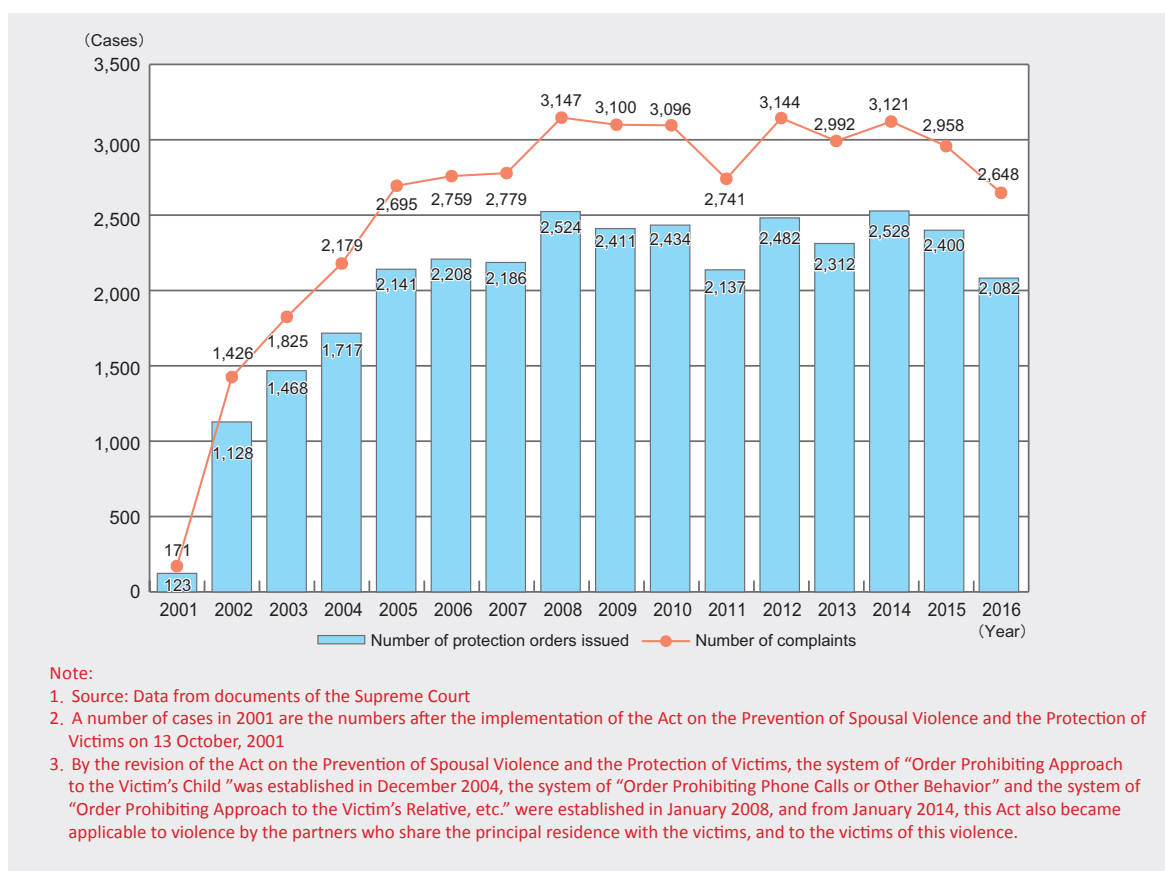
At least one Women's Consulting Offices set up in each prefecture, based on the Anti-Prostitution Act. Based on the Act on the Prevention of Spousal Violence and the Protection of Victims, temporary protection of victims and their accompanying family members is conducted at Women's Consulting Offices or facilities that meet criteria stipulated by the Minister of Health, Labour and Welfare.

● Number of Cases of Protection Orders Issued against Spousal Violence

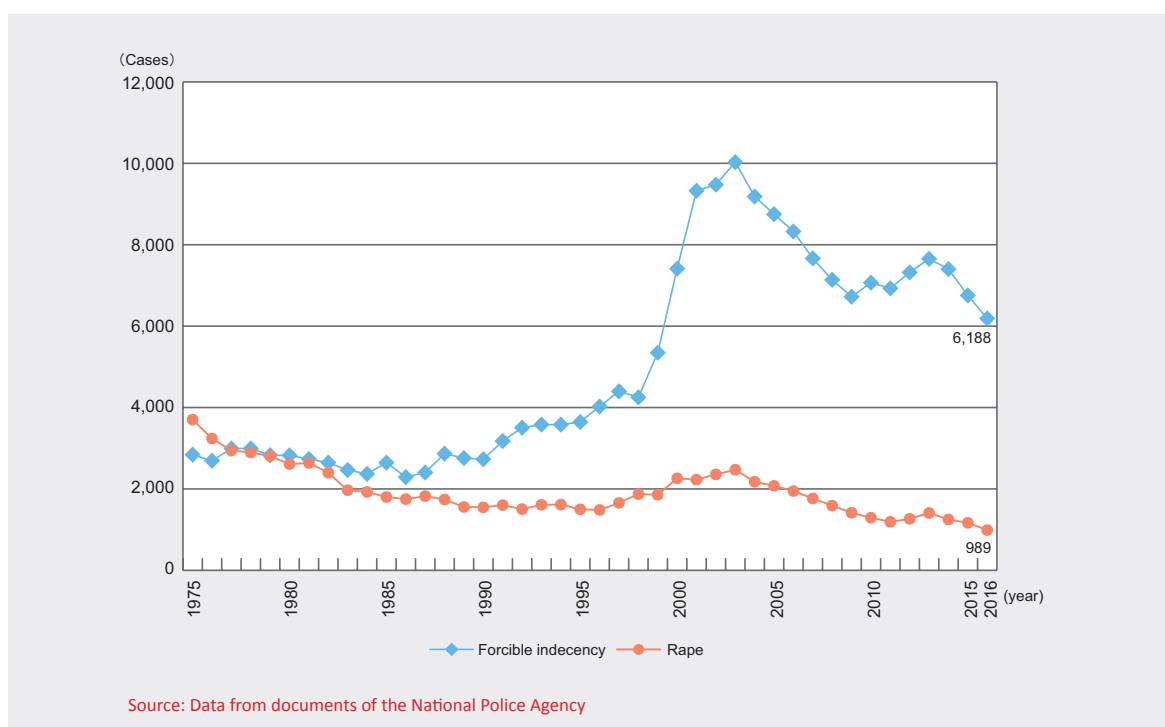
When there is significant danger to a person's life or the threat of serious physical harm due to physical violence by a spouse or intimate partners who share a principal residence, upon request by the victim a court will issue a protection order for the spouse and others, based on the Act on the Prevention of Spousal Violence and the Protection of Victims.



■ Sex Offences

● Number of Reported Cases of Rapes or Forcible Indecencies

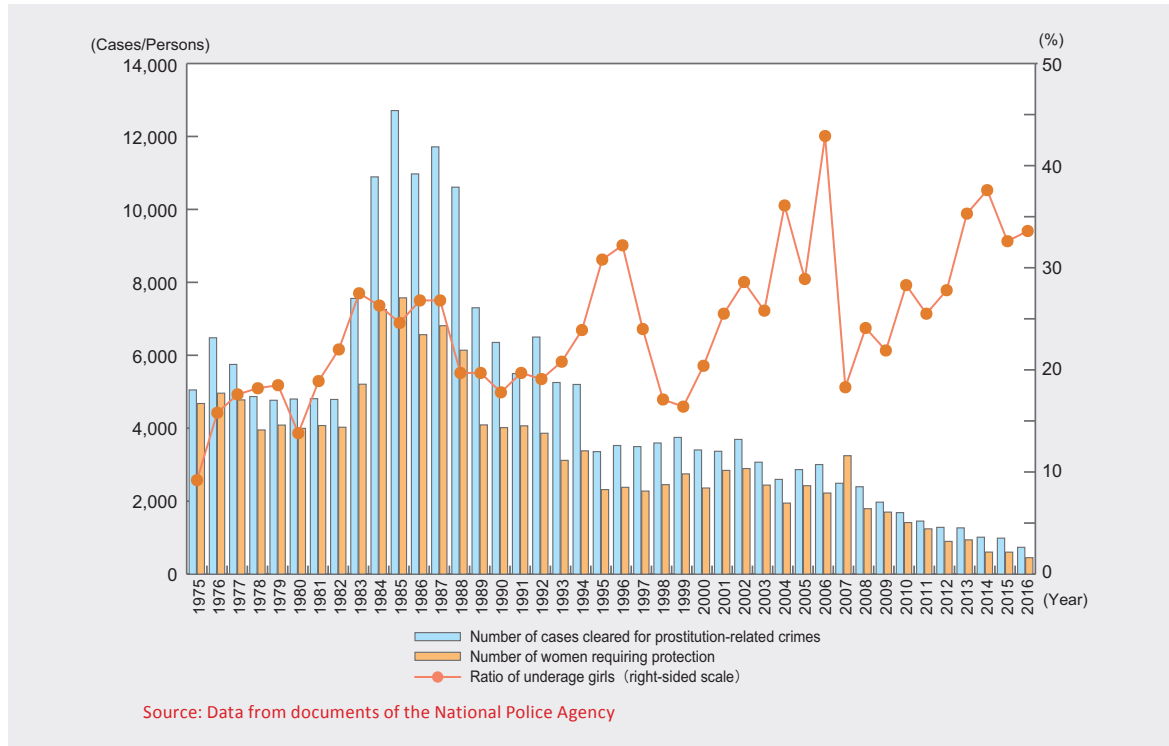
Although both numbers of reported cases of rape and forcible indecencies had been increasing since 2012, they have been declining since 2014.



Prostitution Situation

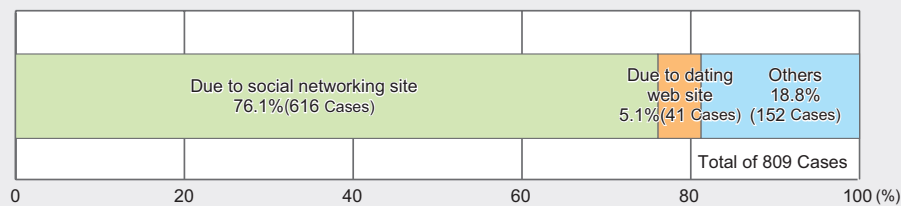
Number of Cases Cleared for Prostitution-related Crime, Number of Women Requiring Protection, and Ratio of Underage Girls

The number of cases cleared for prostitution-related crimes has been declining since 2007 and there is a trend of declining in the number of women requiring protection since 2008.



Number of Cases Cleared for Child Prostitution

The number of cases cleared for child prostitution in 2016 was 809 (81 more than that of the previous year). Of those, 616 (76.1%) arose from use of social networking sites, and 41 (5.1%) arose from use of online dating sites.

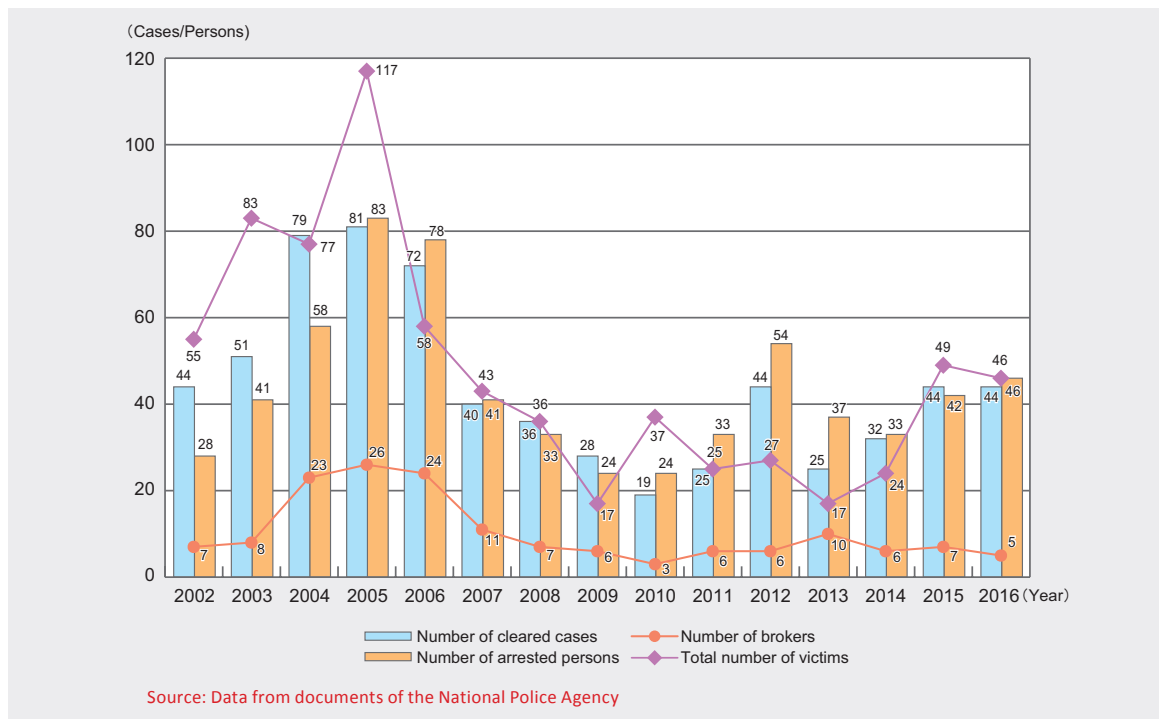

■ Situation of Trafficking in Persons (TIP)

● Number of Cases and Persons Cleared for TIP

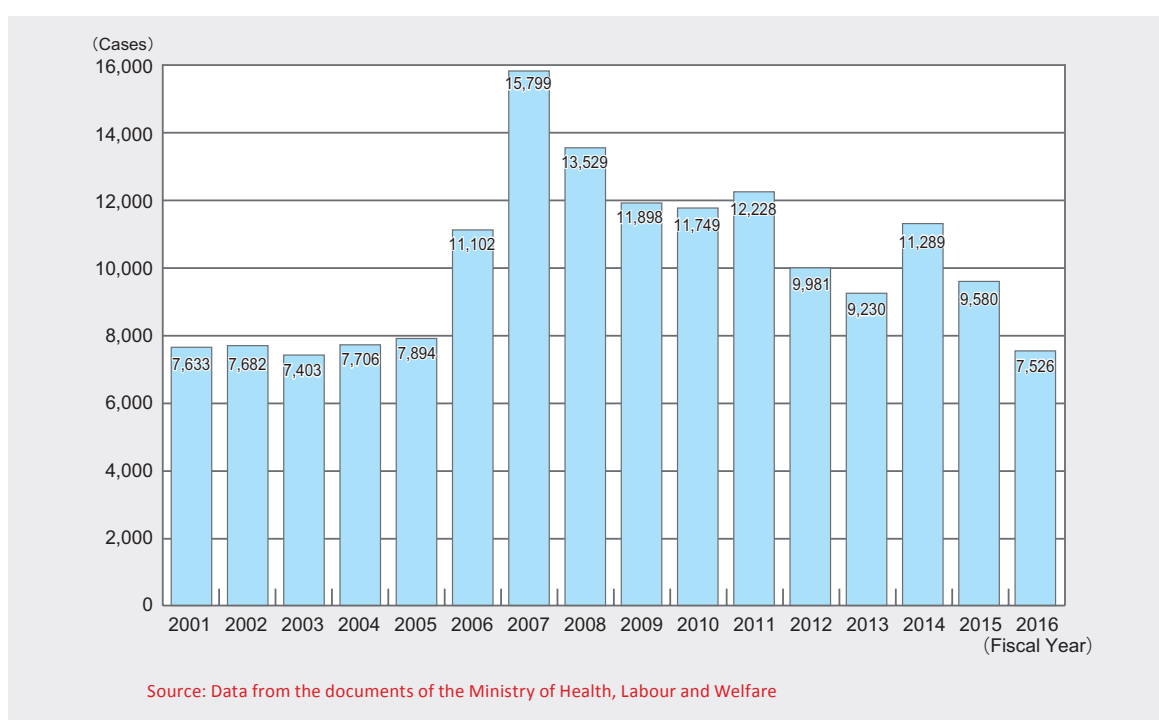
Looking at the situation of TIP, it can be seen that, due to revisions of Penal Code in 2005, the Immigration Control and Refugee Recognition Act and the Act on Control and Improvement of Amusement Business, etc. since 2006 there was a trend of declining in the total number of TIP victims and number of cleared cases. There is a trend of increasing in the number of TIP since 2014.



■ Sexual Harassment Situation

● Number of Consultations about Sexual Harassment

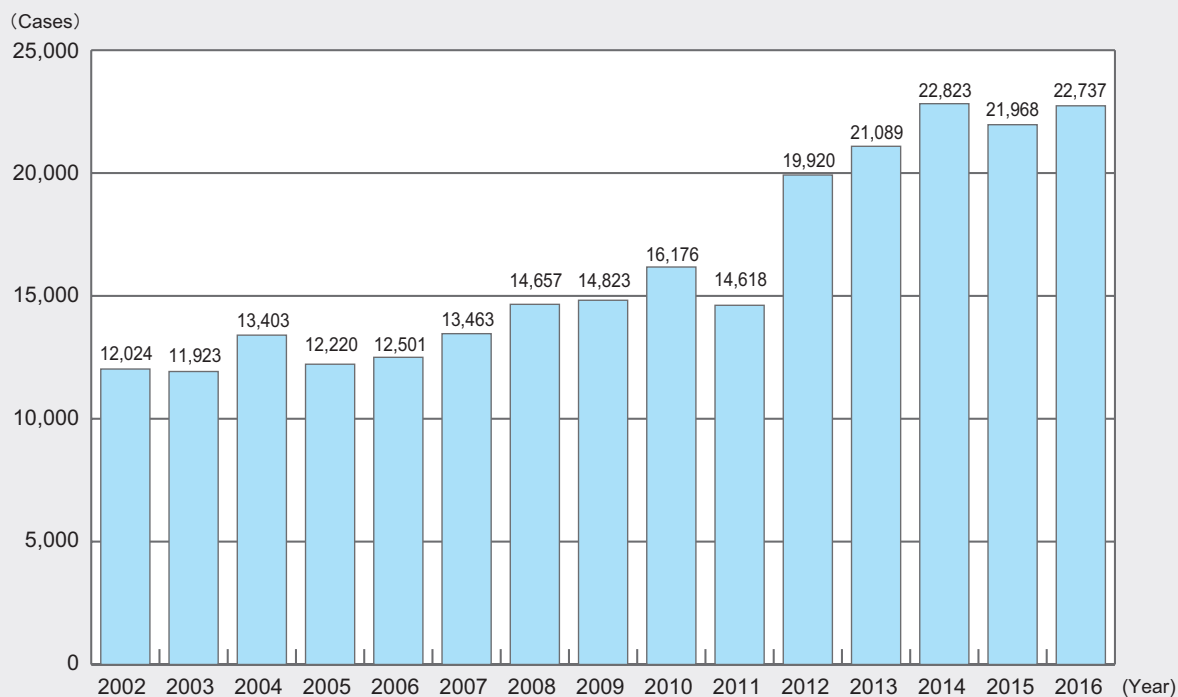
The number of sexual harassment consultations at the Equal Employment Offices at the Prefectural Labour Bureaus in fiscal 2016 was 7,526.



■ Stalker Activity Situation

● Number of Reported Cases Related to Stalker Incidents

The number of reported cases of stalker incidents in 2016 was 22,737, which was an increase of 769 from that of the previous year. 88.8% of the victims were women and 84.0% of the perpetrators were men. The number of cases cleared for violation of the Anti-Stalking Act in 2016 were 769, the highest since 2000, which is when that the Act came into effect.
