# Younger people who frequently use social media are targeted!



A girl was deceived by the sweet words of a man with whom she became intimate on social media and ended up sending a nude picture of herself to him. Taking advantage of that picture, the man threatened the girl and forced her to work in a brothel and prostitute herself. Juveniles, who cannot stay in the family home for some reason, are frequently lured by deceiving words.

## Sexual exploitation in brothels



A woman is forced to work in a brothel to work off her unfair debts.

### Forced labor



Foreigners are forced to do unreasonably heavy work. If they do not comply, violence is used toward them.

## Forced appearance in pornographic videos



A woman applies for a modeling job and fills in a registration form, which is actually a contract, resulting in forced appearance in pornographic videos.

Trafficking in Persons damages both human dignity and rights. It is a serious crime subject to punishment in Japan and abroad.
