Chapter 3

Draft exchange program

1. Outline of the draft exchange program

The agenda for the "Asia-Pacific and African women's exchange program – Toward the eradication of gender-based violence" scheduled to take place in 2021 has been drafted based on the current situation of GBV and challenges faced by each country described in the previous chapters. How and when the exchange program will be held, including an online meeting, will be discussed in the coming Japanese fiscal year considering the state of the COVID-19 pandemic and the border control measures of each country.

(1) Topics of discussion

The following summarizes the three main topics of discussion for the exchange program, based on the information obtained from the basic information survey and needs survey, as well as online information sharing/opinion exchange meetings.

- ① <Policy/system> To establish a better institutional framework and recognize the roles and responsibilities of the public and private sectors.
- ② <Coordination/referral system> To understand the roles of each actor and coordination mechanism so that they can apply new methods.
- ③ < Provision of victim-centered comprehensive care services> To understand the victim-centered approaches for the livelihood restoration of victims.
 - The challenges of social and cultural norms will be discussed as a cross-sectoral issue throughout the program as they pertain to all the three topics.

(2) Exchange program format

The program includes lectures, site visits, discussions (including group exercise), and presentations (including symposium and reporting session).

(3) Date and venue

The program will take place for 16 days (excluding departure and arrival days to Japan) and will be held in Japan (TBD).

(4) Participants (from nine countries)

Two people (One government official and one staff member of a supporting organization) will be selected from each of the following countries.

- Africa: Namibia, Sierra Leone (English-speaking countries)
 - DRC, Burkina Faso, Madagascar, Mali (French-speaking countries)
- Asia-Pacific: Australia, Philippines (English-speaking countries)
- Japan

(5) Structure of the draft exchange program and program objectives

The following are the objectives of each section of the program:
